CORNEAL CYSTINOSIS IS THE BUILD-UP OF CYSTINE CRYSTALS IN THE EYES THAT CAUSES PHOTOPHOBIA (EXTREME SENSITIVITY TO LIGHT) SEVERE EYE PAIN, AND SOMETIMES, BLINDNESS. THERE IS AN EXISTING TREATMENT BUT IT IS RIGOROUS AND REQUIRES HOURLY DOSING OF MEDICATED EYE DROPS. FOR MANY, COMPLIANCE IS DIFFICULT.

IN 2016, CRF FORMED NANOWAFER, INC., FORMALLY KNOWN AS CORNEAL CYSTINOSIS, INC., FOR THE PURPOSE OF RESEARCH AND DEVELOPMENT OF A NOVEL TREATMENT FOR CORNEAL CYSTINOSIS. THE TREATMENT PROPOSES TO USE A NANOWAFER LOADED WITH CYSTEAMINE MEDICATION TO TREAT CORNEAL CYSTINOSIS. CRF OWNS THE LICENSE FOR THE CYSTEAMINE NANOWAFER WHICH WAS DISCOVERED BY A SCIENTIST AT BAYLOR COLLEGE OF MEDICINE.

## CYSTINOSIS RESEARCH HELPS OTHERS

MANY OF THE DISCOVERIES MADE BY CRF RESEARCHERS ARE CURRENTLY BEING APPLIED TO OTHER MORE PREVALENT AND WELL-KNOWN DISORDERS AND DISEASES INCLUDING OTHER CORNEAL DISEASES, KIDNEY DISEASES AND GENETIC AND SYSTEMIC DISEASES SIMILAR TO CYSTINOSIS.
